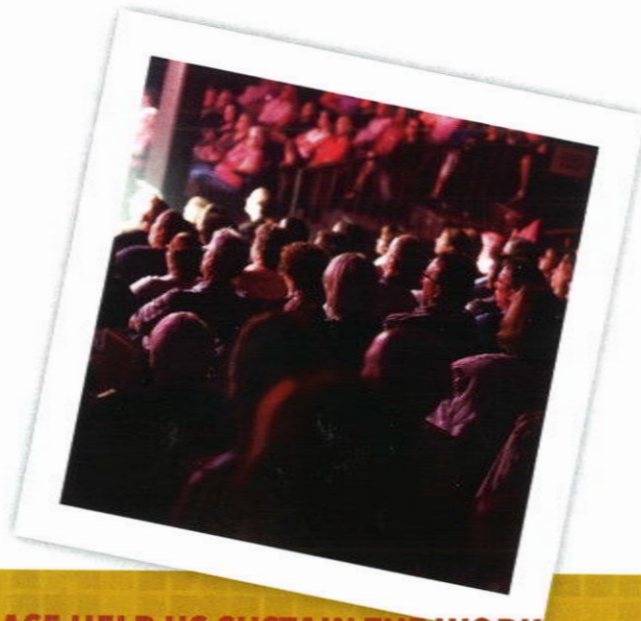

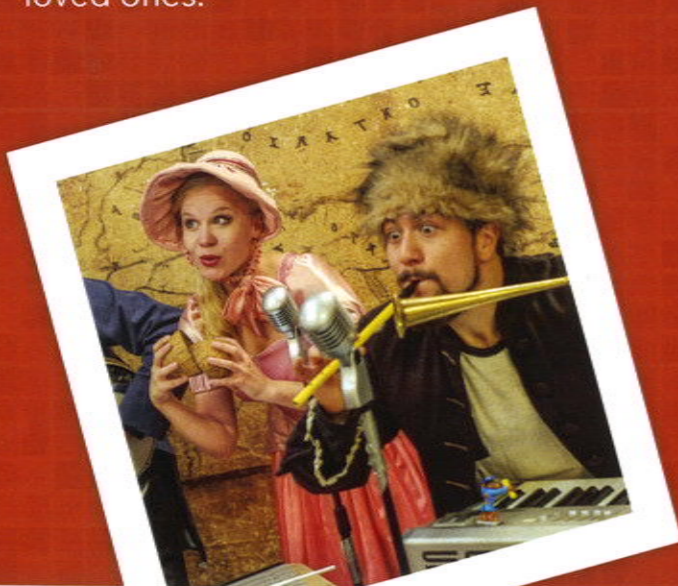
There are several gift arrangements you can choose. These charitable plans let you provide for your family and support theREP. Here are some of the most popular future charitable plans to consider.

Give Retirement Plan Assets

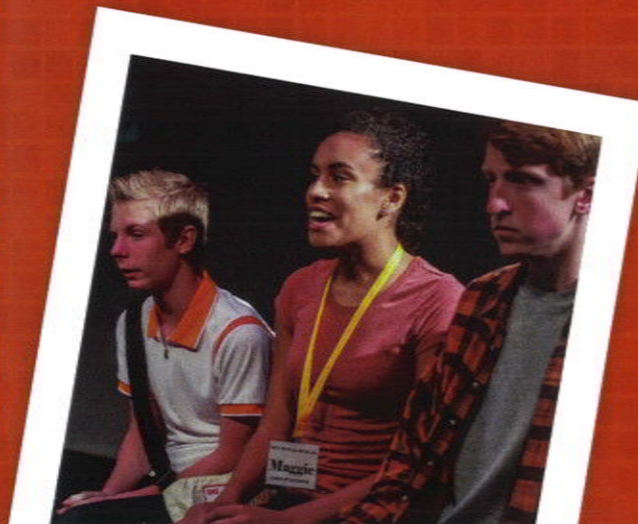
Consider making theREP a beneficiary of a percentage of your retirement plan assets. Then, leave less heavily taxed assets to your loved ones.
